Some Vacant Seats (AFTER WBJEE-2025 E-COUNSELLING) in 1st Year U.G. in Engineering / Technology courses for the session 2025-26 will be filled up through Decentralized Counseling at college level as per the Government notification vide 326-Edn(T)/10M-86/2015 dated 15/09/2025. Accordingly, applications are invited through online mode via this Google link (Decentralized Counseling 2025) from eligible candidates within 20/09/2025 up to 08.00 p.m. Scan copy of Rank Card 2025 and domicile certificate in the format as per Sections 3.4, 3.4.1 and 3.4.2 of Information Bulletin of WBJEE-2025 (in PDF format) should be uploaded.

Provisional list of eligible students for Decentralized Counseling at college level will be published on 22/09/2025 (Monday) at 6 p.m in college website only. No other communication will be made to the students on this matter.

Tentative date for COUNSELLING AND ADMISSION is 25/09/2025 (Thursday) at 01.00 PM. Candidates Must Be Physically Present at the college auditorium to take part in the counseling process. The Date for COUNSELLING AND ADMISSION may change under unavoidable circumstances and the same will be notified in college website. Students are directed to visit college website on regular basis before coming to college on 25/09/2025.

ELEGIBILITY:

- 1. The candidate must have WBJEE-2025 General Merit Rank (GMR).
- 2. Candidates must have passed Higher Secondary (10+2) Examination in General Stream in regular class mode of West Bengal Council of Higher Secondary Education or Equivalent examination from a recognized Council/Board.
- 3. Candidate must be domiciled in West Bengal (Relevant certificate in the specific format should be produced at the time of counseling).
- **4.** Candidate should fulfill all eligibility criteria and the terms and conditions as stipulated by West Bengal Joint Entrance Examination Board in respect of the examination 'WBJEE-2025'.
- **5.** Provisional admission will be made after verification of relevant documents. The provisional admission is liable to be cancelled if any document is found to be false later.
- **6.** Admission under EWS / SC / ST / OBC-A / OBC-B/ PH Quota: The candidate shall have to furnish original and self-attested copies of valid EWS / SC/ST/OBC-A/OBC-B/PH Certificate in his/her name issued by the Government of West Bengal (OBC-A/B /EWS certificates must be issued on or

after 01.04.2025. It must be mentioned that the candidate belongs to the NCL (non-Creamy layer) and subcategory of OBC-A, OBC-B or EWS (certificate issuing authority should be as mentioned by West Bengal Joint Entrance Examination Board in respect of the examination 'WBJEE-2025).

Candidates are requested to take note of the following things.

- COUNSELLING AND ADMISSION WILL BE held according to the **WBJEE -2025** GMR depending upon the availability of seats.
- Only Provisional eligible list of students will be allowed to take part in the counseling process. Other candidates should not come to college on the counseling date.
- The candidate will be called according to WBJEE -2025 GMR and after verification of the documents he/she will get the option to choose the department based on the available vacant seats at that point of time.
- Candidates must produce the original mark-sheets and other certificates for verification, without which no admission will be considered.
- CANDIDATE MUST APPEAR IN PERSON ALONG WITH ALL NECESSARY DOCUMENTS TO TAKE PART IN COUNSELING PROCESS. After the schedule time (1 PM on the date of counselling) no candidate will be allowed to participate in the counseling process under any circumstances.
- COUNSELING AND ADMISSION WILL BE HELD ON THE SAME DATE. NO COUNSELING AND ADMISSION WILL BE POSSIBLE IF THE CANDIDATE IS NOT PERSONALLY PRESENT.
- Counseling and Admission will be closed as soon as the vacant seats are filled up. HENCE ALL
 CANDIDATES MAY NOT BE CALLED FOR COUNSELING IF ALL SEATS ARE FILLED
 UP BY CANDIDATES HAVING HIGHER RANKS IN WBJEE-2025. NO FURTHER
 COUNSELING WILL TAKE PLACE AFTER THE DECLARED SCHEDULE.
- Candidates who have not taken admission in UG Engg./Tech. in Ramkrishna Mahato Government Engineering College (i.e taken admission at other institute/not admitted to any institute) should pay Rs 11,918/- (For CSE and ECE stream) and Rs 8,518/- (For ME, EE, CE stream) as admission fees on the date of counseling. Candidates who have taken admission at other institute (Private/Government) must produce No objection certificate from that institute before university registration.
- Candidates who already took admission in UG 1stYear Courses in this session 2025-26 at Ramkrishna Mahato Government Engineering College and are willing to appear in Decentralized Counseling for stream change will have to bring the following documents in addition to the documents mentioned earlier:
